About Heitz Cellar

Heitz Cellar's tradition of excellence runs as deep as the roots of Napa Valley itself. A family-owned winery since 1961, it has played a pivotal role in shaping American winemaking history. That includes the production of Napa Valley's first vineyard-designated cabernet sauvignon, Heitz Cellar "Martha's Vineyard." As Frank J. Prial of The New York Times put it, "(Martha's Vineyard is) the benchmark by which California Cabernets were judged."

Today, the estate has remained steadfastly committed to classic winemaking values, such as organic and sustainable farming and the use of 100% Napa Valley fruit. In a world full of fads, Heitz Cellar remains timeless.

FUN FACT:

Heitz Cellar was one of the 11 Napa Valley wineries in the iconic 1976 Judgment of Paris. Judge Patricia Gallagher ranked its 1970 Maratha's Vineyard first on her ballot, which helped Napa Valley upset the heavily-favored French.





Why We're Investing

#1-Strong Returns

Good things come to those who wait. For owners of Heitz Cellar "Martha's Vineyard," that means steady returns. Older vintages have averaged a 8.1% return over the last five years, with the 2005 vintage jumping a remarkable 17.4% per year in that time.

#2 - Brand Cachet

When people think of Napa Valley, they think of Heitz Cellars. Founders Joe and Alice Heitz have earned a reputation for classically-styled single-vineyard wines. They also were among the first estates to use French oak over American in the aging process. Today, Heitz Cellar is one of the few Napa Valley wineries worthy of the prestigious "cult cab" label.

#3 - Limited Production

Odds are you've never seen Heitz Cellar "Martha's Vineyard" at your local wine store. That's not a coincidence. Only 4,500 cases of this coveted cabernet are produced each year. With the Heitz Cellar membership at capacity, this collection lets you skip the waitlist entirely.

Inside Martha's Vineyard

Heitz is the exclusive lease holder to the 34-acre Martha's Vineyard in the Oakville AVA. The winery has sourced its proprietary cabernet clone from this fertile, well-draining parcel since 1966. Thanks to the surrounding Mayacamas mountains, the vines receive gentle sunlight in the morning and an oasis of shade in the afternoon; the perfect conditions to express the heart and soul of its terroir.
